PROPOSAL FOR THE DISMISSAL OF THE GOVERNOR OF LAMPUNG OF 2019-2024

BY THE GRACE OF GOD ALMIGHTY
THE REGIONAL REPRESENTATIVE COUNCIL OF LAMPUNG PROVINCE,

- Considering: a. That pursuant to Article 78 Paragraph (1)

 Letter c and Paragraph (2) Letter a, as

 well as Article 79 Paragraph (1) of Law

 Number 23 of 2014 on Regional Government,

 which stipulates that the dismissal of a

 regional head and/or deputy regional head

 whose term of office has ended shall be

 announced by the Chairperson of the

 Regional Representative Council (DPRD) in

 a Plenary Meeting and proposed by the

 Chairperson of the DPRD to the President

 through the Minister for the issuance of

 the dismissal decree;
 - b. That with the conclusion of the term of office of the Governor of Lampung, as stipulated in Presidential Decree Number 49/K of 2019 regarding the Appointment and Inauguration of the Governor and Deputy Governor of Lampung for the 2019-2024 term, it is necessary to issue a decision from the Regional Representative Council of Lampung Province regarding the Proposal for the Dismissal of the Governor of Lampung for the 2019-2024 term;
- In view of : 1. Law Number 14 of 1964 concerning the Establishment of the First-Level Region of Lampung, amending Law Number 25 of 1959 on the Establishment of the First-Level Region of South Sumatra (State Gazette of the Republic of Indonesia of 1964 Number 95, Supplement to the State Gazette of the Republic of Indonesia Number 2688);

- 2. Law Number 28 of 1999 concerning Clean and Corruption-Free State Administration;
- 3. Law Number 12 of 2011 concerning the Formation of Legislation (State Gazette of the Republic of Indonesia of 2011 Number 82, Supplement to the State Gazette of the Republic of Indonesia Number 5679) as amended by Law Number 13 of 2022 concerning the Second Amendment to Law Number 12 of 2011 on the Formation of Legislation;
